Service Description

This platform helps to submit a Products not intended for direct marketing to the consumer request or for factories obtaining an industrial exemption for imported shipments that is not intended for sale or trade, to obtain a shipment certificate such as shipments that are imported by individuals for the purpose of construction or restoration as well as shipments of raw materials products or factory equipment used in production lines, shipments that are supplied to government agency according to a purchase contract and product for national events.

Register an account in the Products not intended for direct marketing to the consumer platform

Step One:

From the home page of the system click on "Register New User".

Choose the registration purpose as "Products not for direct consumer marketing".





Step Three:

After being redirected to the registration page, you will need to select your user type from the available options.

These types include citizen, resident, and others such as government agencies, foreign companies, or any other types.

If you have a facility account in Saber for commercial products as a delegated user or contact officer, you can login directly to the Products not intended for direct marketing to the consumer platform using your existing login credentials.

After agreeing to the pledge, click "Submit." A confirmation window will appear for request submission, and an invoice for your request will be generated.

Step Seven:

Before the payment and to view the SADAD number, you will have to choose whether to apply for a Tax invoice or continue without.

After selecting the "Apply for Tax invoice" option you will be redirected to Amaly portal to obtain a tax invoice.

Note: If the bill has already been paid, it is not possible to make any modification to the Tax invoice.

Payment can be made through the available payment options (Sadad, Mada, Visa, MasterCard, Apple Pay).





After payment is done, the request will be sent to the Consumer Department of products not intended for direct marketing to study the request and make the decision, you can follow up the status through "My requests" page.
